## Remarks:

An ordinary resolution was passed at the extraordinary general meeting of the Company held on 22 March 2021 to approve the fifth amendment agreement entered into between the Company and the bondholder to amend some principal terms of the convertible bonds, including to extend the maturity date of the convertible bonds for one year from 17 January 2021 to 17 January 2022. Its conversion price shall be amended from HK\$0.34 to HK\$0.221 per conversion share (subject to adjustment), which can be converted into the maximum number of 405,542,986 shares of the Company. The interest rate of the convertible bonds shall be increased to 10% per annum and paid annually (the "Fifth Amendments"). Save for the Fifth Amendments, all other terms and conditions of the convertible bonds shall remain unchanged. For details, please refer to the announcement of the Company dated 19 January 2021 and 22 March 2021 and the circular of the

Company dated 5 March 2021. As at the date of this monthly return, the Company has not received any notice of event of default from the bondholder demanding immediate repayment nor notice of exercise of the convertible bonds. The Company will negotiate with the bondholder for the renewal of or further extension on the convertible bonds and disclose further developments on the above matters by way of further announcement(s) in a timely manner in accordance with regulatory requirements.
